ISSUE OF UNLISTED OPTIONS TO KEY STAFF

The Board has resolved to issue 2,500,000 unlisted options to key staff and consultants to the Company, with no Directors participating in the issue. The Board agreed to issue these to key members of EVE's team as part of year end remuneration reviews in June 2008, but due to the uncertain market conditions at the time it was decided to delay the issue. The exercise price was finally set on a 3 month VWAP to 30 September 2008 in order to be fair and reasonable to all stakeholders.

These options are exercisable at 5 cents each on or before 30 June 2012, and will vest to each allottee following service to the Company over two years to 30 June 2010.

In addition to this the Company also advises the cancellation of 350,000 unlisted options exercisable at 16 cents each that were issued on 23 March 2007 due to the allottee having ceased employment with the Company.
